# Executive Director's Letter

It is with a heavy heart that the Maine Turnpike Authority dedicates our 2022 annual report to two men who were true partners in the never-ending task of improving and innovating transportation in the state of Maine, Eldon Morrison and Paul Koziell of CPM Constructors, who died in a plane crash this past fall.

Recent projects by CPM Constructors for the Maine Turnpike Authority include:

- Reconstructing Exit 45 (ongoing)
- Repairing bridges for Ramp J & Wilson Road in Kittery and Littlefield Road in Wells (ongoing)
- Rebuilding, widening, and lengthening the Cummings Road overpass just south of Exit 45
- Accelerated Bridge Construction replacement of Winthrop Street Bridge in Hallowell
- Reconstruction of the interchange at Exit 80 in Lewiston

The Exit 45 Interchange reconstruction is nearly complete. This complicated project required some deep thinking in the design of the project, the materials used, and how to construct it while accommodating everyday traffic through and around the interchange. It is certainly one of the most diversified and difficult construction projects undertaken in Maine this past year. Just days before his passing, at Paul's invitation, I walked the Exit 45 site with him. He was visibly proud of the new interchange. It is a handsome memorial to these leaders in heavy construction. We will miss them both as will their conscientious employees and staff who have worked so closely with us on many successful projects.

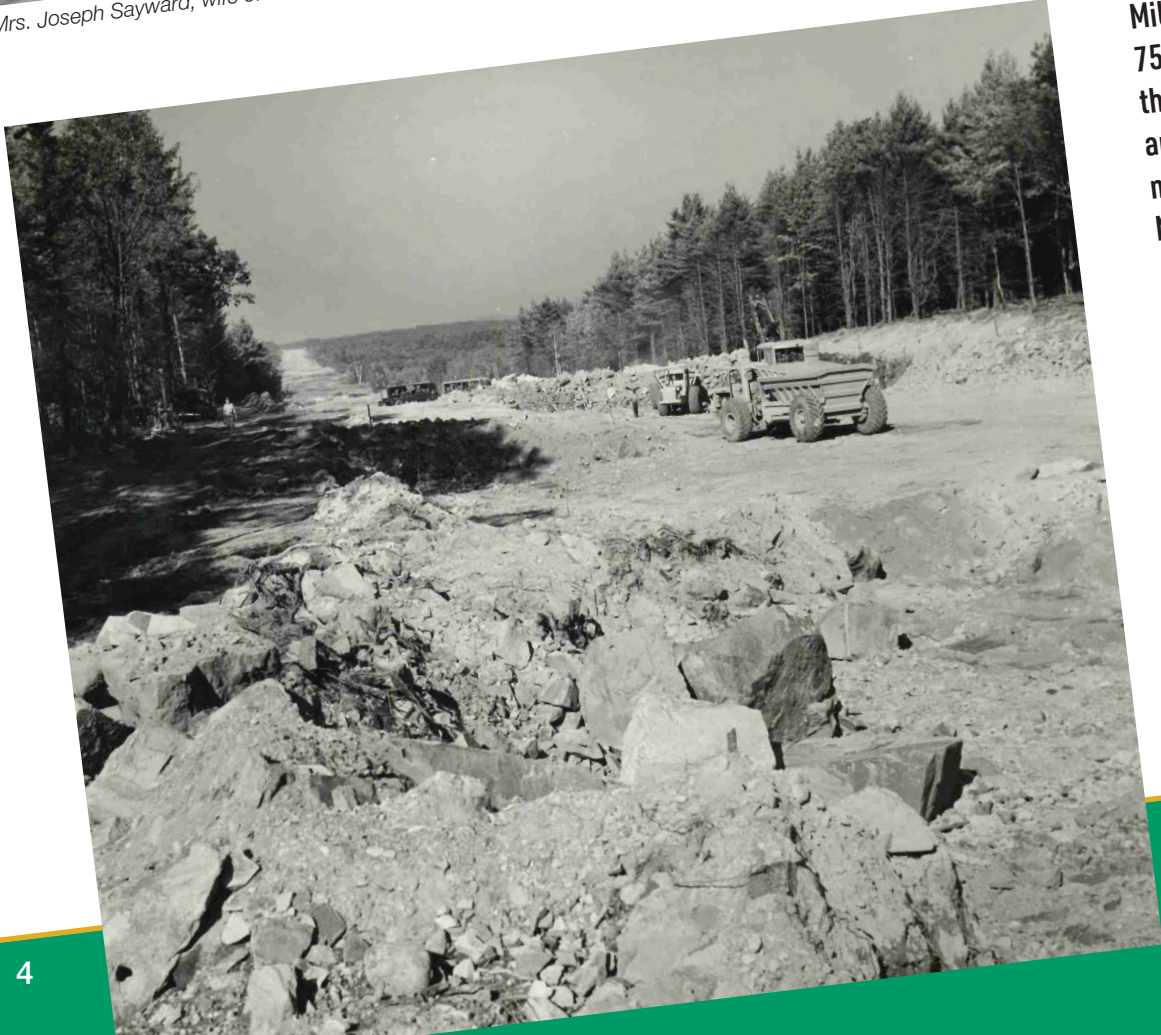

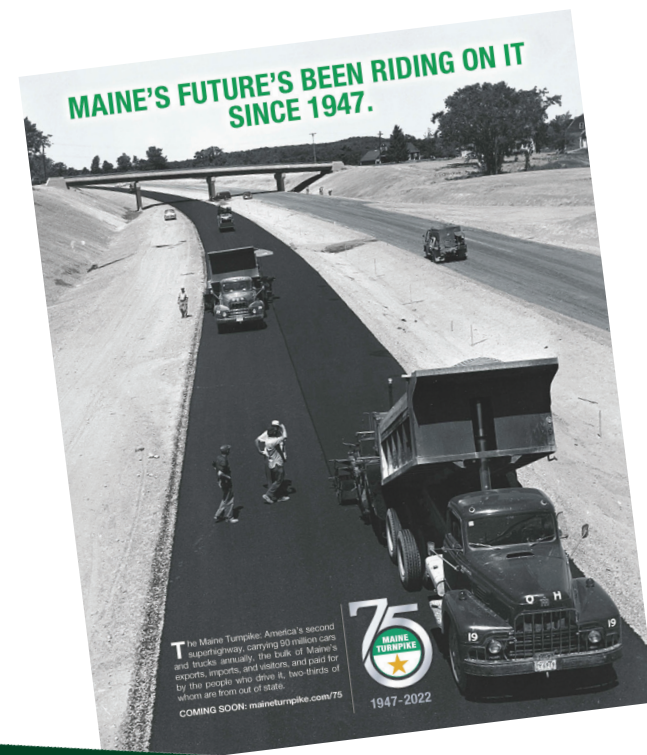




A website was created to commemorate the 75th Anniversary of the Turnpike. It included vignettes of turnpike history, a timeline and interviews

## Exit 45

The reconstruction of Exit 45 (the Maine Mall Exit) in South Portland commenced in 2019, with nearly \$15 million worth of pre-load in order to stabilize the soils for the new bridge and toll plazas. During the pre-load phase, 27,000 wick drains were installed – the equivalent of approximately 430 miles. Work on the Interchange began in the spring of 2021 and included reconstructing Exit 45 as a Diamond Interchange to accommodate growing traffic numbers with two new ramp toll plazas and a taller, wider bridge. The bridge had been hit a number of times in the past and this work included replacing and raising of the bridge to provide a 16.5-foot clearance over the Maine Turnpike. The newly configured interchange opened to traffic in September 2022, shortly followed by the demolition of the old plaza and removal of the old bridge. In 2023 the contract will wrap with some work on the approach road to the interchange.

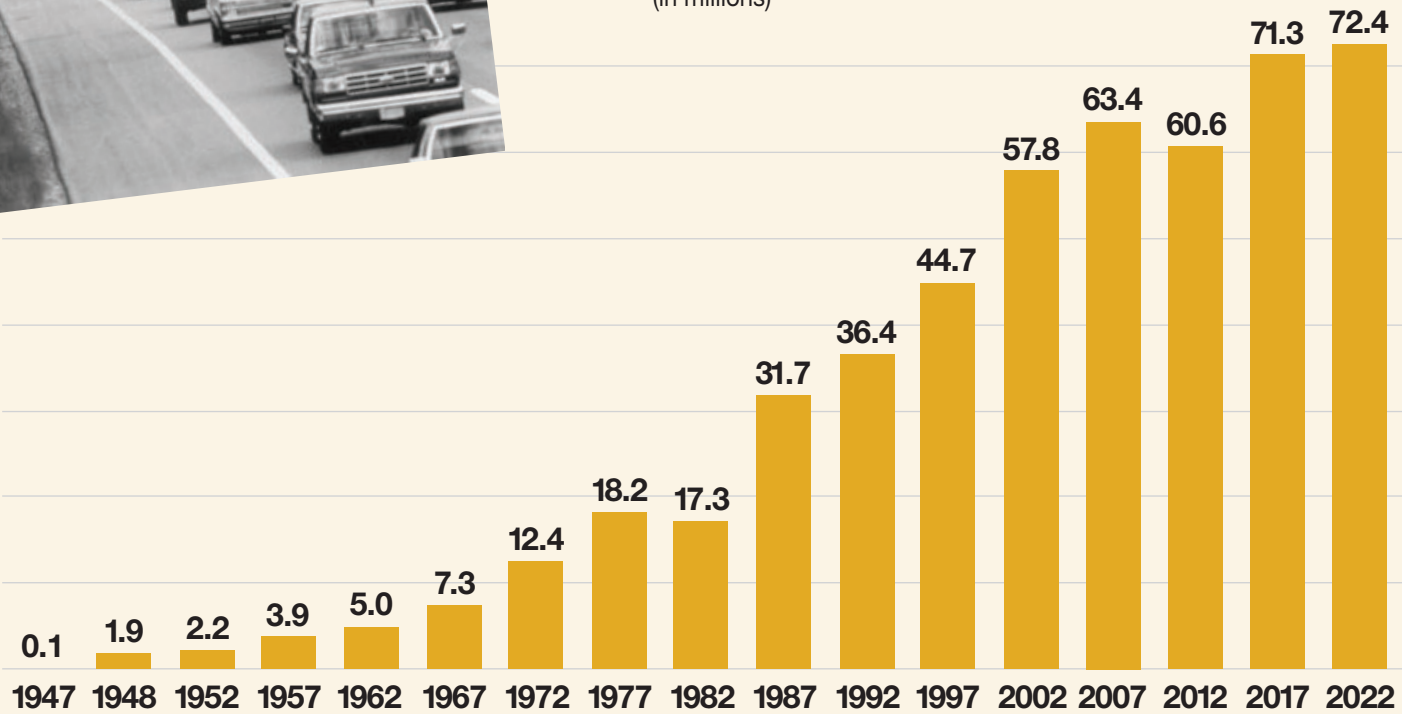




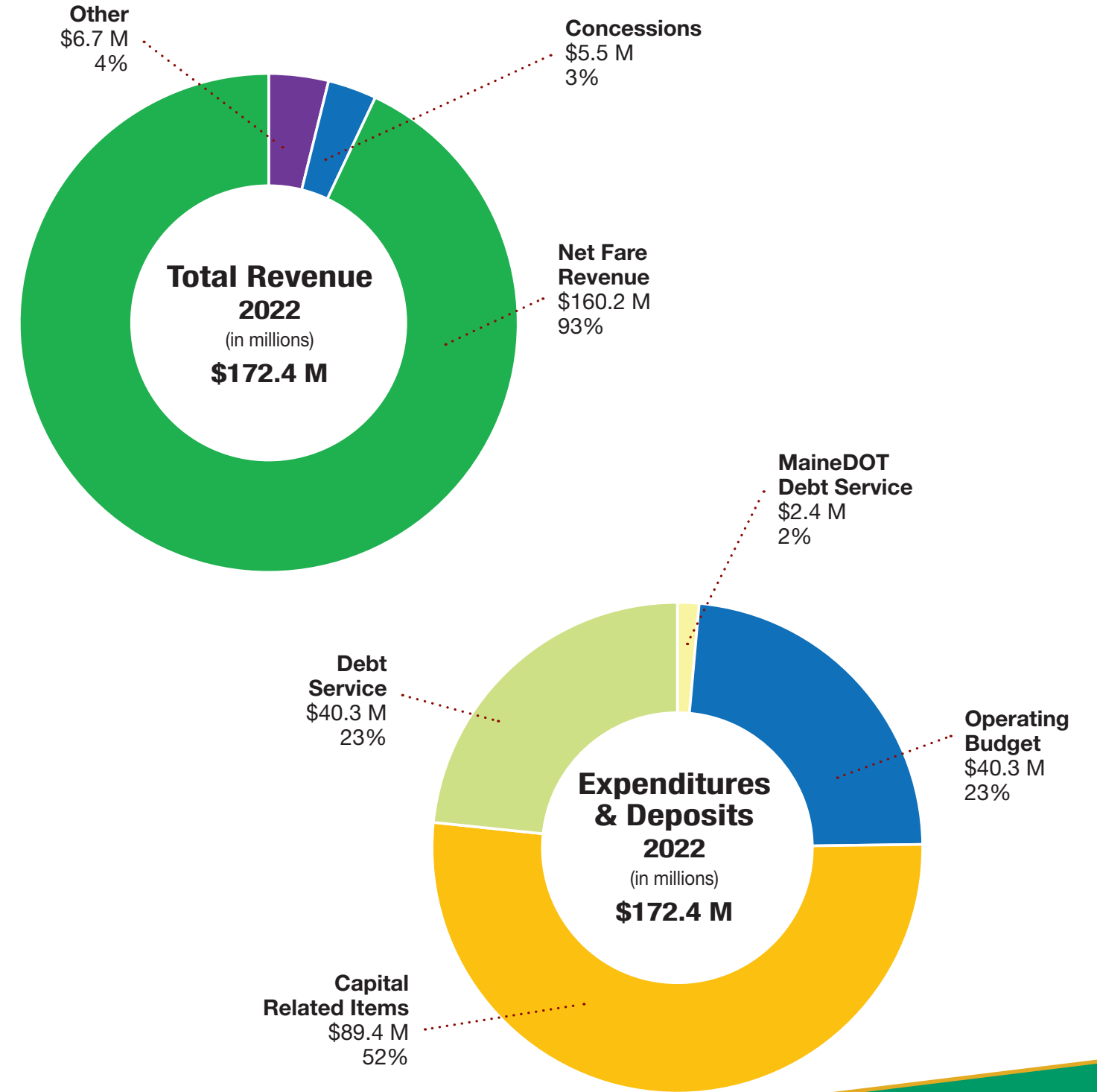
# Traffic Through The Years

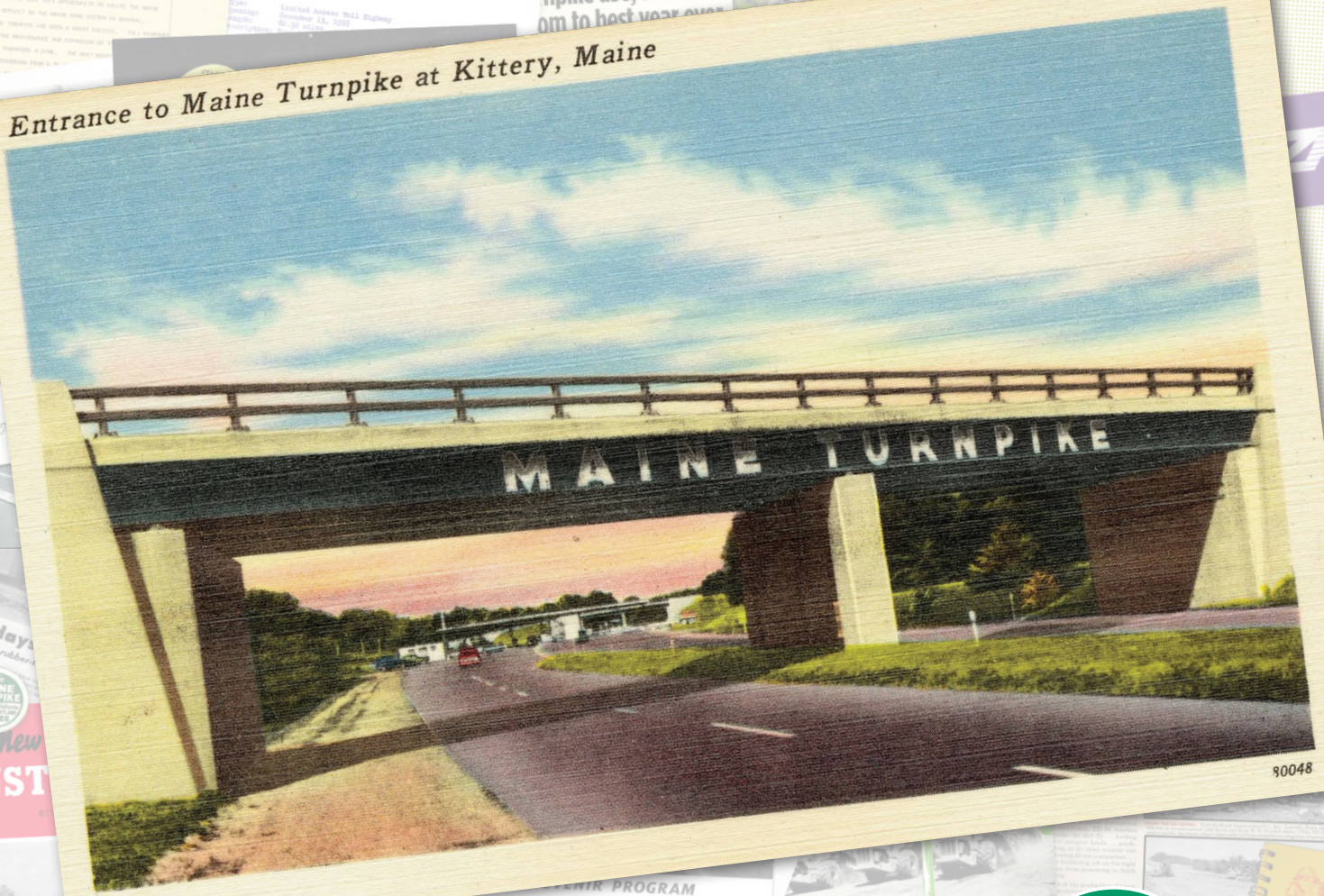
