at the office of the Maine Turnpike Authority, 2360 Congress Street, Portland, ME, until 10:00 a.m., prevailing time as determined by the Authority on March 22, 2011 at which time and place the Proposals will be publicly opened and read. Bids will be accepted from Contractors **prequalified** by the Maine Department of Transportation for Bridge Construction Projects. All other bids may be rejected. This Project includes a wage determination developed by the State of Maine Department of Labor.

The work consists of replacing the Academy Road bridge superstructure and repairing the Route 197 bridge, both over the Maine Turnpike in the Town of Litchfield, Maine.

The Academy Road bridge superstructure work includes superstructure and steel beam replacement, concrete substructure modifications and repairs, approach work and paving, maintenance of traffic, and all other work incidental thereto in accordance with the Plans and Specifications.

The Route 197 bridge repair work includes deck membrane and pavement replacement, concrete deck, pier and abutment repairs, bearing replacement, bridge joint modifications, structural steel repairs and heat straightening of three damaged bridge girders, maintenance of traffic, and all other work incidental thereto in accordance with the Plans and Specifications.

Plans and Contract Documents may be examined by prospective Bidders weekdays between 8:00 a.m. and 4:30 p.m. at the office of the Maine Turnpike Authority, 2360 Congress Street, Portland, Maine. The full size Plans and Contract Documents may be obtained from the Authority upon payment of Eighty (\$80.00) Dollars for each set, which payment will not be returned. The half size Plans and Contract Documents may be obtained from the Authority upon payment of Sixty (\$60.00) Dollars for each set, which payment will not be returned. Checks shall be made payable to: Maine Turnpike Authority.

Bidders shall not contact any other Authority staff or Consultants for clarification of Contract provisions, and the Authority will not be responsible for any interpretations so obtained.

All work shall be governed by the Specifications entitled "State of Maine, Department of Transportation, Standard Specifications, Revision of December 2002", price \$13, (\$16 by mail) "Standard Details, Revision of December 2002" and "Best Management Practices for Erosion and Sediment Control", latest issue. Proposals must be accompanied by an original bid bond, certified or cashier's check payable to the Maine Turnpike Authority in an amount not less than Five (5%) Percent of the Total Amount in the Proposal, but not less than \$500.00. The Bidder to whom a Contract is awarded will be required to furnish a Surety Corporation Bond, satisfactory to the Authority, on the standard Contract Bond form of the Authority, for a sum not less than the Total Amount of the Proposal.

Proposals must be made upon the Proposal Forms furnished by the Authority separately with the Contract Documents, and must be enclosed in the sealed special addressed envelope provided therefore bearing the name and address of the Bidder, the name of the Contract, and the date and time of Proposal opening on the outside.

A pre-bid conference will be held on March 15, 2011 at 10:00 a.m. at the Maine Turnpike Authority, 2360 Congress Street, Portland, Maine.

The Authority reserves the unqualified right to reject any or all Proposals and to accept that Proposal which in its sole judgment will under all circumstances serves its best interest.
