<u>Question 1:</u> Has an asbestos review of the building been completed?

Answer: No, an asbestos review hasn't been completed. The building was built in 1992.

Question 2: Will the MTA consider winter work if an expedited schedule is proposed?

<u>Answer:</u> The Authority is open to discussing completing the work over the winter on an expedited schedule. However, the Contractor's basis for bidding shall reflect the current schedule limitations included in the Bid Documents.

- 1. Location
 - a. The general limits of work are as shown in the Contract Plans.
- 2. General Description
 - a. The work consists of restroom renovations in the Office/5-Bay garage building located at the Maine Turnpike's Litchfield Maintenance area including selective demolition, partition construction, construction of mechanical, electrical, and plumbing components, as well as all other work incidental thereto in accordance with the Plans and Specifications.
- 3. Bid
 - a. October 12, 2023, at 11:00 A.M. at the office of the MTA at 2360 Congress Street, Portland.
 - b. All bid and contractual questions shall be directed to the Purchasing Department (207) 482-8115.
 - c. All questions on plans and specifications shall be in writing and shall be directed to Nate Carll, Purchasing Manager, at (207) 871-7739 or email nearll@maineturnpike.com.

d. All questions must be submitted by 5:00 P.M. on Tuesday October 10, 2023.

- 4. Notification
 - a. Contractor shall notify and obtain approval from the Authority prior to visiting the Project site for field inspection. The contact person is Mr. Steve Tartre (207) 482-8144 or <u>startre@maineturnpike.com</u>.
- 5. Contract Specifications
 - a. The specifications are divided in to three parts: Part 1, Supplemental Specifications and Part II Special Provisions. Building Specifications are included under Section 800 of the Special Provisions.
 - b. The Maine Turnpike Supplemental Specifications are additions and alterations to the 2014 Maine Department of Transportation Standard Specifications and are available on MTA's website.
- 6. Construction Schedule/Prosecution of Work (SP 103.4 and 107.1):
 - a. MTA Board is scheduled to consider the Contract Award on October 19, 2023.
 - b. Construction Schedule:
 - i. All work complete on or before November 29, 2024.
 - ii. Site and building work substantially complete by October 15, 2024 (See SP 107.1.1)
 - iii. Additionally, construction shall not begin until April 16, 2023.
- 7. Maine Department of Labor Fair Hourly Wages (SP 104.3.8)
 - a. Fair minimum hourly rates for 2023 are provided in the project special provisions. The Contractor shall adhere to the 2024 fair minimum hourly rates once they're published.

- 8. Utility Coordination (SP 104.4.6)
 - a. No exterior utility adjustments or coordination is anticipated as part of this project.
- 9. Limitations of Operations (SP 107.1.2)
 - a. Construction of the restroom renovations shall not, in the opinion of the Resident, prohibit the safe and reasonable operations of MTA maintenance crews. The Contractor shall provide clear access through the hallway adjoining the restroom at all times during construction. The contractor shall provide Turnpike staff access to the tool room upon request to access breaker panels, valves, or other equipment housed therein.
 - b. The Contractor shall submit their proposed staging, storage and construction areas for approval to the Resident. The Contractor shall be responsible for minimizing the footprint of the project, and resulting impacts to the MTA, to the extent practical. The Authority will allow the contractor to store materials in the tool room while construction is ongoing.
 - c. The Contractor shall be responsible for maintaining all utility services at all times during construction, except as noted herein. Outages will be allowed between 4:00 p.m. and 6:00 a.m. daily and shall be scheduled and approved by the MTA at least one business day prior to the beginning of any outage.
 - d. All work shall be completed as expeditiously as reasonably possible and in a manner that minimizes disruptions to MTA operations to the extent possible.
 - e. Two porta-potties shall be provided for the exclusive use of Maine Turnpike staff at all times when the restroom is not available for use by Maine Turnpike staff.
- 10. General Requirements
 - a. The Contractor will be required to submit the following for inclusion with the signed contract:
 - i. Contract and insurance certificates, including builders risk policy
 - ii. Schedule of values and pay down schedule for the Lump Sum Restroom Renovation item.
 - iii. Listing of General Contractor's representatives and anticipated subcontractors.
 - iv. Project Gantt schedule identifying project schedule highlighting critical path elements.
 - b. An updated schedule will be required at each of the regularly scheduled progress meetings.
 - c. Contractor shall be advised of the following requirements:
 - i. Record drawings shall be provided in accordance with the Contract Specifications.
 - ii. RFI and Shop Logs shall be maintained. Shop drawings shall have a letter of transmittal.
 - iii. Progress meeting minutes will be developed by the Contractor.
 - iv. Method of payment 15th of the month review pay requisitions, final requisition prior to last day of each month.
 - d. Class III safety vests must be worn at all times.
 - e. The maintenance yard and all its facilities will remain operational during the project. Operations that may impede MTA operations shall be submitted for approval at least 14 days in advance of the work.
- 11. Specific Contract Items:
 - a. SP 800, Litchfield Maintenance Restroom Renovation: Includes all work related to the project.
