To Prospective Bidders:

The Maine Turnpike Authority invites quotations for furnishing its requirement of Branded Unleaded 87 Octane Gasoline for highway maintenance facilities for a period of twelve months, beginning November 1, 2026, in such quantities as may be required to be delivered on an on-call basis at locations designated by the Maine Turnpike Authority between York and Gardiner inclusive.

Included with this invitation is a list of points of delivery, the storage capacity of the tanks and estimated usage. The total estimated quantities listed on the attached form are to be considered approximate for a period of one full year. The amounts may increase or decrease and are to be solely for the compiling of quotations. Payment to the Vendor will be made only for the actual quantities of Gasoline delivered.

All quotations shall be based upon rack price per gallon plus an escalator and should include all shipping costs for all locations for a twelve-month period beginning November 1, 2026, and shall be net price exclusive of all Federal & State Excise Taxes. Given the current market conditions the MTA is not looking to lock in pricing for the year. Payment by the Authority shall be NET30.

If the vendor fails to provide the necessary Gasoline at the quoted price or fails to deliver within a 24-hour period from order placement, the Authority shall have the right at its own option to terminate the deliveries by written notice, without any liability whatsoever. The vendor shall be liable for all costs to the Authority caused by fuel outages.

Throughout the term of the Agreement, the contractor shall maintain at his or her expense Comprehensive General Liability insurance with a minimum coverage of \$1,000,000.00 per occurrence, \$2,000,000.00 in aggregate; automobile liability insurance with a minimum coverage of \$1,000,000.00 per occurrence covering his or her activities on the project premises. The contractor shall also maintain at his or her expense \$500,000.00 of worker's compensation insurance coverage. Please submit proof of insurance with proposals.
